

Annual report for David Lane for the academic year 2015-2016

Information David Lane continued work on alternatives to neo-liberal capitalism as well as on developments in post-Soviet countries. His teaching in Cambridge University included a course (jointly with Dr J. Miley) on the MPhil on Modern Societies on Alternatives to Global Capitalism. He continued research on a number of themes: alternative social formations to global capitalism, the formation of the Eurasian Economic Union. He organised, and gave a paper entitled Post-Socialist Regions in the World System to, a workshop on The Eurasian Project in a Global Context which was held in the sociology department on 9 December 2015. The contributions were published in European Politics and Society (detailed below). In January 2016, he gave a public lecture in London organised by the Society for Cooperation in Russian and Soviet Studies on What Prospects for the Eurasian Economic Union? In March 2016, he gave a paper at the Moscow Economic Forum on 'The School of Critical Political Economy' and in May 2016, presented a lecture entitled: Which Way Forward for the Eurasian Economic Union? at the International Seminar on 50

Conceptualising development and Cooperation in Eurasia, held at Jesus College, Cambridge. Also in May 2016, he gave a plenary paper at the International Political Economy Congress, at Rostov on Don, Russia, on Post-Capitalism as a New Economic system.
