## Report by the Head of the Sociology Department

I would like to take the opportunity to take stock and explain briefly what the department has achieved in the past year.

With regard to research, we have reconfigured our research profile around three themes: social theory and culture; science and technology; and politics and inequalities. Science and technology involves sociological engagement with media and digital technologies, as well as biomedical sciences and reproductive technologies. These three pillars capture very well the research conducted within the department, whilst also providing a broad guideline for its intellectual direction.

Within the School of Humanities and Social Sciences, Sociology has the second highest grant income of all departments, this despite its small size. Some of our recently appointed UTOs have been remarkably successful in obtaining large research grants (Ella McPherson, Monica Moreno Figueroa, Stuart Hogarth), whilst others have been receiving prestigious prizes and fellowships that provide evidence of academic distinction (Hazem Kandil). Our success in obtaining grants has also resulted in a large and thriving postdoctoral community; many of our postdoctoral researchers go on to become Principal Investigators themselves, running successful research teams.

With regard to teaching, we congratulate Monica Moreno Figueroa who won the 2017 Pilkington Teaching Prize. The prize did not come as a surprise to us as students' feedback on Monica's teaching has been tremendous. The department now houses three Pilkington Prize winners. Within our department, Gavin Stevenson won the 2016-17 Supervisor Award – congratulations to Gavin.

With regard to undergraduate teaching, our Part II intake is steady, circling around 100 students (taking single or joint tracks with Sociology) for the whole of Part II. The university has finally given the green light for the Part II Sociology and Criminology joint-track within the HSPS Tripos; this will start on 1 October 2018 and will therefore be available in Part II next year to the 2017 HSPS intake.

Our postgraduate student applications have been increasing, especially in our MPhil, where we have been allowed to take on more students. For 2017-18, we will have 36 incoming Master's students for the MPhil in Sociology, 11 for the newly created MPhil in Health, Medicine and Society and 16 new PhD students. Note that the university envisages an increase of the postgraduate student body as part of its strategy to counteract the financial fall-out of Brexit, so our increasing numbers are in line with this. In the context of postgraduate training, Maria lacovou's work as Director of the Social Science Research Methods Centre has been tremendous; the Centre now provides methods training for roughly 2,000 postgraduate students across the university.

In the last couple of years, the department has made great strides in linking with neighbouring disciplines and STEM subjects: Sarah Franklin's successful research team on reproductive

sociology has gone from strength to strength, and Stuart Hogarth's recent arrival in our department has led to the establishment of an exciting ERC-funded research group on biomedical innovation. Sarah Franklin also helped to set up the new interdisciplinary MPhil in Health, Medicine and Society, a joint arrangement between Sociology, Social Anthropology, and History and Philosophy of Science, in which several members of our department teach, including Stuart Hogarth, Noemie Merleau-Ponty, Robert Pralat, Marcin Smietana, Lucy van de Wiel and Darin Weinberg. This new MPhil will start on 1 October 2017.

Within the administrative staff, we hired Elaine Paterson, our first Outreach and Communications Coordinator. This position, which we created last year, has been particularly helpful for departmental outreach, for our website and for our use of new media. During the short spell that Elaine has been with us, she has done excellent work. Together with Ella McPherson and Rikke Amundsen, she has redesigned our website, which now looks slick, upto-date and user-friendly. Elaine also helped me to finalise the programme for the first Jo Cox memorial lecture, to be held in Murray Edwards College on 20 October 2017: our guest speaker will be Kevin Watkins, CEO of Save the Children. I am particularly grateful to Barbara Stocking, President of Murray Edwards, for providing the auditorium and college facilities and for helping to organise the event. Elaine will be leaving mid-October to take up a position of Media and Communications Officer at the International Union for the Conservation of Nature; we wish Elaine all the best and will be advertising for a replacement within the next couple of weeks.

Jackie Scott will be retiring at the end of this academic year and we should all be immensely grateful for the enormous amount of work she has done for the department. Jackie was head of department during a particularly difficult spell, we owe considerable gratitude to the way in which she was able to steady the ship, and I very much hope that Jackie will remain an active part of the department. On behalf of the department, I wish Larry King well in the US; Larry was with us for more than a decade, establishing Cambridge as a centre for the political economy of health. He has now moved to the Economics Department of the University of Massachusetts, Amherst.

As of 1 October, Sarah Franklin will be taking over as head of department. Sarah has the drive and imagination to lead the department at this very important juncture. She has been very much involved in key decisions over the last 6 months and there is no doubt that this will lead to a very smooth transition. (30 September 2017)

### Report by the Director of Undergraduate Education

In 2016-17, 622 undergraduates studied HSPS, with 194 students enrolled in Part I Human, Social and Political Sciences tripos, 216 in Part IIA, and 212 in Part IIB. The **first year sociology** paper was as usual popular: **194** Part I students took this course, including 3 students from Economics and 13 from Psychological and Behavioural Sciences. In the HSPS **Part IIA** tripos, **27** students opted for the **Sociology stream** and 35 for the combined Soc/Soc Anth or Soc/Pol streams. In **Part IIB**, 28 opted for **Sociology** and 18 for the combined Soc/Soc Anth or Soc/Pol streams.

Gavin Stevenson, PhD candidate, won the 2016-17 **Supervisor of the Year Award**. At the beginning of June, the department announced the first ever Supervisor Award for staff and students who had supervised our undergraduate students. Students from across the HSPS Tripos were asked to nominate their supervisor for this exciting new award; we received nominations from around 40 students. Students were asked to evaluate their supervisors based on criteria such as organisation, communication and essay support and were invited to leave comments. Having considered the submissions, Gavin was the obvious winner, with 10 nominations. He received a £100 prize.

### **Report by the Director of Graduate Education**

The Department admitted 27 new MPhil students in 2016-17, very comparable to the number in the previous year. The Department has restructured its MPhil programme into 4 distinct pathways, Modern Society and Global Transformations, Political and Economic Sociology, Sociology of Media and Culture, and Sociology of Reproduction. From October 2018, Modern Society and Global Transformations will be replaced by a new pathway on Marginality and Exclusion. The pathways create give more structure and intellectual coherence to the course and they are proving to be very successful. In 2017-18 the number of applications to our MPhil programme surged, rising from 167 in 2016-17 to 251 in 2017-18. Partly in response to this, we were allowed to increase the intake to the MPhil: in 2017-18, we admitted 36 new MPhil students, which is the largest number MPhil students we have ever had in the Department.

For the PhD programme, we admitted 18 new students in 2016-2017. This was down on the previous year but very close to the average of the last 5 years. Of the 18 new PhD students admitted in 2016-17, around 40% (i.e. 7) were students who had completed our MPhil with excellent results and were allowed to progress to our PhD programme.

Overall we had 27 MPhil students and 93 PhD students in the Department in 2016-17, or 120 graduate students in total. This large graduate community is at the heart of what we do as a Department. We are fortunate to be able to attract some of the very best graduate students from all over the world and they make an invaluable contribution to the research culture of the Department.

We are poised to expand the graduate community even further in the coming years. The School of Humanities and Social Sciences, of which our Department is part, has approved a plan to increase our graduate intake by 30% over the next 4 years, compared to a growth of around 15% for the University as a whole. This would take our new admissions to 48 MPhil and 22 PhD students by 2021-22. This is excellent news for the Department and for students wishing to join the sociology graduate community in Cambridge.

Nine PhD theses were submitted and approved in 2016-17. The PhD completion rates within four years for the cohort that started in October 2013 was over 83%, the highest for many years and above target. Congratulations to all of those who submitted in a timely manner. As a reward we have introduced a new scheme whereby PhD students submitting within four years are eligible for 'affiliated researcher' status in the Department. Congratulations to Charlotte Proudman who has been elected to a Junior Research Fellowship at Queens' College, and to Kusha Sefat whose dissertation, *Tehran: The Politics of Things*, was awarded the 2016-17 Best PhD Dissertation of the Year on a Topic of Iranian Studies by the Foundation for Iranian Studies.

As in previous years, a full programme of doctoral training and support was provided in 2016-17. Each first-year PhD student presented their research to the group in Lent Term. The quality of the presentations was very high and the exercise was so successful that it will become a permanent feature of the first-year programme.

The number of specialist reading and seminar groups for graduate students continues to increase year-on-year, and the Department encourages staff and students to form active clusters based on research interests. The Department's provision of funding for these groups has given them more freedom to invite outside speakers and to organize reading weekends.

The strong participation of sociology in the Social Science Research Methods Centre (SSRMC) has been beneficial to our own graduate students' training in qualitative, quantitative, historical and web-based research methods; some courses were provided by sociology staff, others by university teachers in cognate disciplines. It has been reassuring to see a substantial increase in the number of our own students taking these courses.

The Department was fortunate to have very active and hard-working graduate student representatives in 2016-17, Amarpreet Kaur and Rijak Grover for the MPhil and Mahvish Ahmad and Mohamed El-Gendy for the PhD, and the Department is very grateful to them for the substantial contributions they made to improving the welfare of graduate students. The Department also congratulates the new student reps who have been elected for 2017-18, Julia Hotz and Madeline Johnson for the MPhil and Rashmi Singh and Gavin Stevenson for the PhD, and looks forward to working closely with them in the coming year.

## **Research Groups and Teaching Centres**

### Individual in the Labour Market Reading and Research group

The ILM reading and research group has now been active for 16 years. Since 2015, the group has been co-chaired by Vincent Hardy and Magdalena Soffia, with the support of Dr Brendan Burchell. The ILMRG operates as a platform for enriching debates and analyses in the fields of economic sociology, industrial relations, employment and social class.

The group is mainly composed of staff and postgraduate students from Sociology, but membership is in constant renewal. Past and present members have hailed from Psychology,

Human Geography, Economics and Development Studies. We are delighted to announce that five incoming MPhil and PhD students have already expressed interest in joining the group.

#### Highlights

The activities of the ILM during the reporting period began with a successful 3<sup>rd</sup> edition of the annual research retreat. As in previous years, the retreat took place Southwold, Suffolk and was held between the 28th and the 31st of October 2016. Thanks to the additional funding for research clusters awarded by the Department, 10 students could take part in a weekend of academic discussions, reading sessions and social activities by the beach.

The reading sessions resumed with impetus after a year of intermittent meetings in 2015-16 due to the ILMRG's collaboration with the *Rethinking Work* seminar series. Around 12 fortnightly meetings (4 per term on average) were held this year. In an attempt to give a breath of fresh air to our regular discussion sessions, classic texts in the field of sociology of work and employment were incorporated to the reading list, starting with an interesting reading by Stephen Marglin (1974); *What do bosses do?* The rest of the theoretical and empirical readings discussed throughout the year included authors like Graeber (2016), Fernandez-Macias and Hurley (2016), Costas & Karreman (2016), Jokela (2015), Olin Wright (2016), Standing (2016), Levine & Turab Rizvi (2005), Bent (2017), Stuetzer et al. (2016), Seron et al. (2016), and Ravenelle (2016). All the articles have been compiled in the new ILM Moodle site, which began operating in October 2016 and has served as the archive of all ILM activities.

In February, we also hosted a guest speaker, Kirsten Sehnbruch, Director of the Public Policy Institute at the Universidad Diego Portales in Chile, who gave a talk on measuring the quality of employment in developing countries. Moreover, several visiting scholars joined us for parts of the year. Dr. Nora Gray from the Pontificia Universidad Católica de Valparaiso in Chile, Lara Monticelli, from the Scuola Normale in Florence and Baris Alpaslan, assistant professor of economics from Ankara Yildirim Beyazit University.



### ReproSoc – Reproductive Sociology Research Group

The Reproductive Sociology Research Group (ReproSoc) is based in the Department of Sociology and located in the Mond Building on the New Museums Site. The research group is led by Professor Sarah Franklin who established ReproSoc in 2012 with support from the Vice Chancellor's Fund. Over the past five years ReproSoc has worked closely with many other University of Cambridge centres, colleges and departments to develop and promote the distinctive interdisciplinary research collaborations that have established Cambridge as the undisputed world leader in the burgeoning field of reproductive studies.

ReproSoc supports a wide range of research projects on reproduction and new reproductive technologies, from undergraduate to post-doctoral levels. Situated at the intersection of reproduction, culture and technology, ReproSoc research projects generate empirical and theoretical findings that enable us to better understand and characterise social processes such as the biologization of technology, the commodification of reproductive substance, the increasing overlap between fertility and infertility, national variation in the regulation of reproductive technologies, and the increasing importance of reproductive and regenerative processes within the economy. Our work thus contributes to many fields including sociology and anthropology, science and technology studies, social and oral history, law and economics, as well as bioethics, social theory and the new kinship studies.


Since 2012 **ReproSoc** has increased in size from 3 to 25 staff and postgrads who together have been awarded more than 35 grants and studentships totalling over £5M from a range of sources including the British Academy (1), ESRC (8), ERC (1), Philomathia Foundation (2), Wenner Gren Foundation (1), Wellcome Trust (3), Gates Foundation (5), Mellon Foundation (1), Sociology of Health and Illness Foundation (1), British HIV Association (1) and Cambridge Trusts (4). We have a steady pipeline of research grant applications under review and in preparation, and our success rate to date is over 75%.


Our projects reach an increasingly large audience and our collaborations significantly expanded in our fifth year. The IVF Histories and Cultures Project, ChinaReproTech, 'Life in Glass', Reproducing the Environment, SurrogARTs, Men's Attitudes to Intimate Life (MAIL), Life in Translation and Changing Global In/Fertilities are the largest of our collaborative projects, linking us to many partners in the UK and around the globe including many of the world's largest IVF centres. We work closely with the British Library, the Royal Society, the British Academy and many key sector charities and trusts including the Fertility UK, the Progress Educational Trust, the Anne McLaren Memorial Fund and the Edwards and Steptoe Trust. The flagship journal, *Reproductive Biomedicine and Society*, is co-edited by Sarah Franklin and Martin Johnson and based in Cambridge. Our website is home to an increasingly wide range of social media through which we expand our outreach and engagement, coordinate our activities, and

consolidate our research findings. We publish a weekly blog and a quarterly newsletter to publicise our work and encourage interaction with our research.

In addition to an extensive research programme, ReproSoc hosts Visiting Scholar programmes for PhD students and established academic staff, a speaker series, a film series, and an outreach programme involving collaborations with artists, filmmakers and a design team. We host an annual public lecture which in 2016 was presented by Dr Marcia Inhorn of Yale University, based on her new book Cosmopolitan Conceptions (Duke 2015), and accompanied by a book launch of Katie Dow's new book Making a Good Life from Princeton University Press. All of the postdocs are involved in teaching and supervision as well as running our new MPhil programmes in the Sociology of Reproduction and in Health, Medicine and Society. ReproSoc conferences, workshops, and publications have attracted large and appreciative audiences at Cambridge and beyond, increasing the group's reputation as a key player in a rapidly emerging subdiscipline. The support we receive comes from a broad base including scientists, clinicians, policy makers, parliamentarians, artists, journalists, patients, archivists and funding bodies as well as other academics. Media and outreach remain priorities for us, in addition to supporting and producing high quality research and publications through innovative interdisciplinary collaborations.

ReproSoc began the 2016-2017 academic year larger than ever and we were especially pleased to be joined by the inaugural group of MPhil students launching our new postgraduate programme in the Sociology of Reproduction. In November 15 members of the ReproSoc team took part in an interactive exhibit at the London Fertility Show in partnership with the Liminal Space design team. This provocative engagement exercise has left us with lots of food for thought! Other highlights for the Life in Glass project were the premiere of Karen Jent's new film 'Dish Life', featured in the Cambridge Shorts programme, and our ongoing work with the photoartist Gina Glover at Bourn Hall. Nitzan Peri-Rotem's paper and panel at the Philomathia Symposium extended our research on 'Changing Fertilities', which is now the focus of some very exciting new planning and fundraising efforts.









Lent Term 2017 was packed with landmark events for ReproSoc, allowing us to look both forward and back. Our visit from Paul Woodgate from the Wellcome Trust gave us the opportunity to review our progress to date and identify core themes that are emerging and priority areas for new research, publication and workshops. The themes of reproduction and the environment, the IVF-stem cell interface, changing in/fertilities, reprosexual health, egg freezing, IVF histories and cultures and 'life in glass' were featured on our new blog

site at reprosoc.com, and our new outreach webpage at lifeinglass.net. A new ReproSoc video for Instagram is part of an ongoing effort to develop our public engagement capacities, and we have several new videos in production for our YouTube channel. All of these creative forms of expression help us to think about our work from new directions. and with new audiences in mind. The dynamic and thought-provoking Biocircularities conference with which we ended last term, organised by Branwyn Poleykett and Karen Jent, and featuring a brilliant panel on the film 'Dish Life', powerfully demonstrated how making new visual media can inspire creative critical thought. We hosted talks by Dr Martine Lappe of Columbia University and Dr Jennifer Takhar from the Paris Chamber of Commerce, as well as a workshop with Fertility Activist and author Jessica Hepburn Sadly we had to say goodbye to Dr Nitzan Peri Rotem, who has made such a brilliant contribution to our team, but has a wonderful new post at Exeter, Congratulations were due to the recipients of major prizes and awards this term: ReproSoc MPhil student Amarpreet Kaur was awarded an ESRC PhD studentship, Sociology of Reproduction Lecturer, Dr Mwenza Blell, was nominated to receive the highly competitive Graduate Tutor of the Year award from the University Vice-Chancellor, and both Dr Noemie Merleau-Ponty and Dr Lucy van de Wiel won major awards for their PhD dissertations from the Netherlands and France.





Lent term also saw the launch of a new research project, Life in Translation, led by Dr Noemie-Merleau Ponty, Professor Sarah Franklin and Karin Jent. During Easter Term 2017 we hosted the highly successful workshop on 'Reproducing the Environment' organised by Katie Dow and Janelle Lamoreaux. We also held workshops on the 'Life in Glass' project led by Dr Lucy van de Wiel and we visited Bourn Hall with our collaborators Gina Glover and Jessica Hepburn for a packed session devoted to Gina's residential photo art project there. An entire field of corn was grown over the summer at Murray Edwards

College, where our exhibit 'Reproductions' will be held next June, and it will accompany a major international conference entitled Remaking Reproduction: the global politics of new reproductive technologies.

# Cambridge Undergraduate Quantitative Methods (CUQM) Centre



This report covers the period October 2016 to September 2017 and gives details of the many activities that have happened over the past year including a well-attended and interesting annual lecture, many short courses and a very successful undergraduate event on the measurement of inequality that packed a large lecture theatre.

The initial funding for CUQM was for three years, April 2014 until April 2017. We now have a better sense of what has worked well and should become a more enduring feature of CUQM's contribution, and which aspects of our work need to be adapted to meet our goals.

The increased uptake of undergraduates into QM undergraduate Tripos papers has also been very successful. The POL6 paper has been an outstanding success with 35 politics students enrolled on that course in 2016-17, and a further 14 students enrolled on SOC5. The accompanying SPSS workshops run by Dr Sparkes and assisted by Bryant Hu received very positive feedback from the students. Out of the 37 students who filled in feedback forms in Michaelmas, 26 (70 percent) rated the quality of the teaching in the workshops as 'excellent', and 24 (65 percent) rated the quality of the academic content as 'excellent'. The SOC5 course has the largest intake yet of Sociology and Education students for 2017-18, with 20 students. These increased numbers of students with QM skills is feeding through to a larger proportion of undergraduate dissertations using quantitative methods, and the standard of the entries for CUQM's quantitative dissertation prize has been reassuringly high for the last two years.

The pre-term introductory statistics courses continue to be very popular and oversubscribed, particularly those timetabled in October and January. A total of 72 students signed up for the three courses across all affiliated CUQM departments. The feedback we receive from these courses continues to be outstanding. Of the 43 students surveyed at the end of the courses, 35 (or 81 percent) rated the quality of the teaching as 'excellent'. No student stated that the teaching or organisation was 'acceptable', 'poor' or 'very poor'. The introductory course thus proves to be in very high demand and of great benefit to students from across the social sciences. We are very fortunate to have retained Dr Matthew Sparkes in his role as the main provider of these courses, while many Q-Step centres in other universities have suffered from high levels of staff turnover.

Embedding QM into substantive courses is still a main aim of the centre (see: <a href="https://www.cuqm.cshss.cam.ac.uk/Embedding-Quantitative-Research">https://www.cuqm.cshss.cam.ac.uk/Embedding-Quantitative-Research</a>). Dr Mónica Moreno Figueroa asked the Centre to assist with the analysis of the 2015 Mexican Intercensal Survey which had incorporated a racial/ethnic self-identification for black people. Dr Sparkes produced numerous tables and graphical analyses for Dr Figueroa to use in her lectures. CUQM will continue to look for opportunities to integrate QM teaching into the undergraduate Triposes, and this role will be spearheaded by a senior UTO to act as 'QM champion' for the social sciences and humanities.

As an additional outlet for engaging students in quantitative methods Dr Burchell and Dr Sparkes decided to trial a workshop around a current and topical quantitative theme. The 'Measuring Inequality' workshop took place on 25 January 2017, with Dr Pedro Ramos Pinto (Faculty of History) and Dr Ben Alcott (Department of Education) delivering interesting and engaging presentations, and Dr Anna Vignoles and Dr Alice Reid acting as discussants. The interest in the workshop was exceptionally, and surprisingly, high: 129 students from across the Social Sciences obtained a ticket

through Eventbrite. With the success of the event, the workshop will become an annual event in the CUQM calendar and will take place at the start of Lent Term. The next workshop will cover 'Big Data', and organisation for the event has already started.

The 2017 annual lecture was delivered by Andrea Lee, the Deputy Director and Lead Analyst of Children, Families and Disadvantage at the Department of Work and Pensions. The lecture 'Children, Families and Disadvantage: Using Evidence, Analysis and Data to Improve Children's Outcomes' took place on 9 March 2017 and was well attended by undergraduates, postgraduates and academics.

For the second year running, CUQM has worked with YouGov to provide a six-week summer placement to students who have undertaken a statistics paper or one of the CUQM short courses. This year we had 14 applications for the placement, and YouGov commented on the high quality of the applicants. Having reduced the pool to three candidates, they selected Nick Partington (POL6) for the six-week internship.

A short video clip has been produced by Justin Hodgett, an AV/IT Support Technician from the Faculty of Education. Dr Burchell, Professor Vignoles, and Dr Sparkes took part in the video, as did a number of students who undertook either SOC5, POL6 or one of the CUQM short courses. We would like to express our sincerest thanks for the professionalism and skill shown by Mr Hodgett in the making of this video, and for the considerable time he spent on producing it.

The School of Social Sciences and Humanities has been giving much thought to the future funding of CUQM, and the best way to plan and deliver CUQM's activities. Initially, it was agreed to continue funding CUQM for a further 12 months (until March 2018) while longer-term arrangements could be considered. Matthew Sparkes has continued in the Teaching Associate role for CUQM, but also took over the administration functions from Siobhan Hoffman-Heap who in now fully employed by the SSRMC. We are very grateful for the assistance we have received from Siobhan in the past 18 months. Discussions about the longer term basis for CUQM have focused on the possibility of rationalising the funding of CUQM and the Social Science Research Methods Centre (SSRMC). The centres have much in common in providing research methods training across the University, but also important differences. CUQM and SSRMC will thus continue to have separate identities and their own distinctive 'front ends'. We will experiment with some dual activities – for instance, undergraduates will be allowed to book onto some of the more specialised SSRMC quantitative courses. where uptake for CUQM courses has been low. The main benefits will be 'behind the scenes' where many of the functions are similar – for instance, in the booking system for courses and providing better and more varied employment for the Teaching Associates.

### **Social Sciences Research Methods Centre (SSRMC)**

The SSRMC provides training in research methods to postgraduate students at both MPhil and PhD level, across the University. Each year we offer 40-50 modules covering basic statistics, the use of software packages, qualitative methods, survey methods, and advanced quantitative methods. Students from across all six Schools take our courses, with the strongest participation being from our participating Departments (Criminology, Education, Geography, History, Land Economy, Linguistics, Music, Politics and International Studies, Social Anthropology, Psychology, and Sociology). Bookings for core SSRMC modules increased from 1405 in 2014/15 to 1730 in 2015/16; in addition, several students attended "open access" modules in departments other than their own.

Core funding for the SSRMC is provided by the Schools of Cambridge University; teaching is paid for via this core funding, with additional teaching contributed by participating Departments. In 2016-17, one module was also paid for by the University's ESRC-funded Doctoral Training Centre, via an Advanced Training Network grant.

SSRMC modules are taught by a range of instructors, including Cambridge UTOs, affiliated lecturers and researchers, some PhD students with advanced skills, and some visiting experts.

Towards the end of the 2016-17 academic year, the SSRMC was expanded to incorporate some of the activities of Cambridge Undergraduate Quantitative Methods (CUQM). CUQM will retain its own "badge" within the University and will remain responsible for promoting the uptake and understanding of quantitative methods, while the SSRMC will take on responsibility for taking bookings for undergraduate modules and teaching these modules. Under this arrangement, Dr Matthew Sparkes (0.5FTE Teaching Associate for CUQM) joins the staff of the SSRMC; the new budgetary arrangements also make provision for the hours of work of the SSRMC Administrator to be increased to full-time.

Bookings for SSRMC modules continue to increase year on year. In 2014-15, the SSRMC took 1405 bookings; this increased to 1727 in 2015-16 and to 1972 in 206-17. This increase partly reflects an expansion in provision; it also represents higher take-up of our existing modules, particularly our basic statistics stream, in line with a growing awareness of the importance of this type of training.

The 2017-18 academic year sees the SSRMC retaining the same core provision as previous years. In addition, we have introduced a number of short courses and workshops in the following areas: sampling; weighting and imputation; mixed methods; data quality; and power analysis. These topics were identified in response to staff and student feedback, as well as the recommendations for research methods training set out by the ESRC.

#### Research Grants:

He is currently working on two funded research projects. 'The Digital Revolution in Publishing', funded by a four-year grant from the Mellon Foundation (2013-17), is a direct continuation of his work over the last decade on the transformation of the publishing industry. Whereas his previous two books examined the overall transformation of academic and trade publishing over the last 50 years, this new project focuses specifically on the digital revolution and its impact on the publishing industry. It examines how both established publishers and new start-ups on the margins on the field respond to the challenges of digitization and seek to innovate in a rapidly changing information environment. It also explores the broader implications of these developments in terms of the role of technology in the creative industries and the future of the book and other forms of cultural dissemination. The fieldwork is now complete and he is currently completing a book, *Book Wars: The Digital Revolution in Publishing*, that will be published 2018.

The second project is a continuation of the collaborative research with Manuel Castells and others on the financial crisis and its aftermath. Following the publication of Aftermath: the Cultures of the Economic Crisis, they have been working since 2013 on a multi-stranded research project on 'The Crises of Europe' with senior scholars from around Europe; this is funded by the Gulbenkian Foundation in Lisbon and the Fondation Maison des sciences de l'homme in Paris. Linked to this project, he is also directing a research project on 'The Human and Social Costs of Economic Crisis', funded for three years by the Balzan Foundation (2014-17). This project is exploring the ways in which individuals live through and experience economic crisis; it takes a bottom-up approach, studying in a close, ethnographic way the daily lives of ordinary individuals experiencing the effects of crisis. The first outputs from these projects appeared in 2017 with the publication of *Europe's Crises*, which he edited with Manuel Castells, Olivier Bouin, João Caraça, Gustavo Cardoso and Michel Wieviorka (Cambridge: Polity, 2017), 434pp + xiv. Included in this volume is an article on "Suffering: The Human and Social Costs of Economic Crisis", which he wrote with Eirini Avramopoulou and Silvia Pasquetti (*Europe's Crises*, pp. 148-77). They are continuing

to do fieldwork in Greece and Italy for the Balzan project and further publications will appear in the near future.

In addition to these projects, he is working on two new initiatives. One is the digital society initiative, which seeks to develop an innovative interdisciplinary collaboration between social scientists and computer scientists in order to examine the most fundamental and far-reaching questions concerning the impact of the digital revolution on social and political life. The second is a collaborative project examining the new challenges and opportunities faced by the book publishing industry, submitted to the AHRC Creative Industries Clusters Programme.
