Report by the Head of the Sociology Department

ı

The Department of Sociology became a stand-alone department within the Faculty of Human and Social Sciences in August 2012. Sociology was formerly part of the Department of Social Sciences, together with Social and Developmental Psychology (SDP). We wish our colleagues in SDP well as they merge with Experimental Psychology to create a new Psychology Department in the School of Biology. These infrastructural changes should help Sociology consolidate and build on its research and teaching excellence. It also provides the structure for Sociology to participate fully in the launch of the new Human Social and Political Science Tripos, from October 2013 onwards.

Teaching

Sociology in Cambridge continued to win acclaim for its undergraduate teaching programme. Cambridge Sociology was top again in the 2013 edition of the Complete University Guide and it was ranked 4th in the QS World university Ranking by Subject in 2011, thus rated in the top four sociology departments in the world together with Harvard Berkeley, and Oxford. This exceptional record of success attests to Cambridge's standing both nationally and internationally as one of the pre-eminent institutions for the study of sociology.

The graduate community in sociology remains large and vibrant. The MPhil in Modern Society and Global Transformations continues to attract a large number of applicants, and all 26 students enrolled in the 2011-12 programme successfully completed the course. In 2011-12 there were 77 students registered for PhD research in Sociology, including 22 new students joining the programme. Many of our students have secured highly competitive research scholarships from the ESRC, Gates Foundation, and Cambridge Trust.

Departmental Seminars

The Department continued its high profile series of Sociology Seminars and open lectures. We had a number of well-known visiting speakers, including Michael Mann, (UCLA); Tak Wing Chan (Oxford) and Heejung Chung (Kent). The Seminars were well attended by staff and graduate students, and they provided a forum in the Department for the discussion of sociological research.

Publications

All members of the Department have been very active in research. A fuller account of the publication outputs can be found elsewhere in the Annual Report, but it is worth highlighting here some of the many books that have been published this year including: The Politics of Knowledge (Dominguez and Baert (eds)); Social Stratification: Trends and Processes (Lambert, Connelly, Blackburn and Gale (eds)); Elites and Identities in Post-Soviet States (D Lane (ed,)); Power in the 21st Century: Conversations with John Hall (M.Mann); The Source of Social power: Vol 3: Global Empires and Revolutions (M. Mann); Gendered Lives: Gender Inequalities in Production and Reproduction (Scott, Dex and Plagnol (eds)); Sick Societies: Responding to the Global Challenge of

Chronic Disease (Stuckler and Sigel). Health Care Reform and Globalisation: the US, Europe and China and Europe in Comparative Perspective (Watson (ed.)).

David Stuckler's book *Sick Societies* was "highly commended " by the British Medical Association. A new edition of Brendan's Burchell's edited book '*Introducing Social Psychology*' was translated into Arabic. John Thompson's new paperback edition of *Merchants of Culture* got considerable media attention and was chosen as book of the week by the THES and was included in Books of the Year by the TLS.

Media, Press and Outreach

The Department participated fully in the Cambridge Festival of Ideas; with talks on work; student protests; the left in crisis; the rise of Satre and French Existentialism; and Contemporary revolution in religious life. Sociology participants included Burchell, Fowler, Sassen and Sennett, Baert, and Lehmann. In addition, Brendan Burchell, Richard Sennett and John Thompson all participated in the Cambridge Stream of the Hay Festival. Cambridge research continued to attract media attention with the international and national press giving generous coverage to King's work on pharmaceutical lobbying and King and Stuckler's work on mass privatization and growth in post-communist countries; Scott and Plagnol's research on work-family conflict; and Stuckler's work on suicide, the economic crisis and food companies and health.

Research Grants

The Department continued its stellar record in winning research grants and contributing to this important stream of university income.

New grants include a British Academy Award and Leverhulme Trust Award to Patrick Baert for studying the Rise of French Existentialism; an EC FP7 Award to David Stuckler for developing methodologies to reduce health inequalities; a British Academy Award to Sarah Franklin on IVF History and a Eurofound Award for Brendan Burchell on Gender and Working Conditions.

Staff Changes

We congratulate Dr Ruth Gaunt on her appointment to a Readership in Psychology at the University of Lincoln. We will also be sad to say goodbye to Sue Tostevin who was administrator for Social and Developmental Psychology from 2009 – 2012. Other departures include Pia Schober (ESRC Research Fellow), and Jessica Hymas (Graduate Assistant Secretary). We extend a warm welcome to Sarah Franklin, Hazem Kandil, David Stuckler, Peter Webb and Gerald McLaren, as well as to our academic visitors for 2011-12.

Report by the Director of Undergraduate Education

This was my last year as Director of Undergraduate Education as I am handing over to Dr Peter Webb.

In 2011-12, 400 undergraduates studied PPS, with 131 students enrolled in Part I PPS, 133 in Part IIA, and 136 in Part IIB. The first year sociology paper was popular: of the 131 Part I students, 123 took this course. In Part IIA, 25 students opted for the Sociology stream and 6 for the combined Psychology-Sociology stream. In Part IIB, 41 opted for Sociology and 11 for the combined Psychology-Sociology Stream.

Xue Chu (Magdalene College) won the **Polity Prize** for Part I. In Part II the Polity Prize went to Stephanie Schohl of Jesus College and Luke Billingham of Trinity Hall. Stephanie also won the joint Sociology and Psychology Prize. We congratulate all of them.

The undergraduate programme and examinations ran smoothly.

In collaboration with our colleagues in the Department of Social Anthropology, we organised a Social Anthropology and Sociology **Sutton Trust Summer School**. Members of our department taught half of the course. The Sutton Trust Summer School is aimed at year 12 (or equivalent) students from UK-state-maintained schools. The student feedback was very positive.

Report by the Director of Graduate Education

Cambridge Sociology continues to offer a high quality postgraduate training programme at both the MPhil and PhD levels, and to attract an increasing number of outstanding students who benefit from excellent research facilities and an unparalleled intellectual environment. The Department offers a one-year MPhil programme including a range of taught elements, and a three-year PhD programme comprising well over 100 students in total. A total of 103 graduate sociology students were registered in 2011-2012: 26 MPhils and 77 PhDs.

The Cambridge Sociology Graduate programme is overseen by a committee that meets three times a term, and is comprised of the Head of Department, the MPhil and PhD programme Directors, the PhD Research Training Co-ordinator, the Chair of the Graduate Education Committee, and the Graduate Education Administrator. All aspects of Graduate Education, including admissions, teaching, supervision and examination are additionally overseen by the Faculty Degree Committee, which is also the degree awarding body, and the Student Registry, whose Code of Practice ensures a high level of oversight guiding student support, evaluation and progress.

The Cambridge Sociology Graduate programme continues to grow and in 2011-12 maintained high rates of admission at both the MPhil and PhD levels. On 1 October 2011 there were 22 new students registered for the PhD degree, of whom 4 had continued from the MPhil. Funding for studentships was provided at both MPhil and PhD level from a range of sources, including (list details). Between 1 October 2011 and 1/10/12 the Graduate Education Committee received 86 applications for MPhil places of which 26 (30%) were accepted: (20 from UK/6 from Overseas); and 78 applications for doctoral study of which 22 (28%)were admitted: (8 from UK/14 from Overseas).

Given their crucial importance to the life of the department, we have continued to improve our core facilities and offerings in order to provide the very highest standard of

provision, including continual improvements in both training opportunities and access to resources. Our graduate students enjoy a dedicated study area, online forums, access to world-class research facilities, and a widening array of personal and professional development opportunities. Cambridge Sociology is home to many of the leading scholars in their fields, who both supervise MPhil and PhD dissertations across a wide range of topics, while also mentoring students and providing career guidance. In 2011 an accredited ESRC Doctoral Training Centre for social sciences which provides world-class resources as an internationally-recognised centre of academic excellence was launched at Cambridge.

Other changes in 2011-12 have also directly benefitted the graduate programme in Sociology. The restructuring of the Faculty that has enabled Sociology to gain greater administrative and intellectual independence has improved the sense of identity and community within the Graduate programme at both PhD and MPhil level. In addition to the well-attended Departmental seminars where postgraduate students at all levels participate in discussion, the PhD students also organise and present their own seminar series of work-in-progress as well as topical reading groups. The dedicated PhD research area on the floor above the Faculty offices is home to a regular series of social events and scheduled coffee breaks, where new and established doctoral candidates can interact and also initiate new ventures, such as the highly successful Careers Workshop organised by Sociology doctoral students for the first time in 2012 in response to popular demand.

In addition to contributing to the intellectual community, sociology PhD students make an important contribution to the undergraduate teaching, providing a valuable opportunity to develop their communication and teaching skills. PhD students have the opportunity to gain teaching experience through undergraduate small-group teaching, for which they are paid by colleges on an hourly basis. Support for doctoral contributions to undergraduate teaching and supervision is provided centrally through the comprehensive range of Personal and Professional Development courses offered at Cambridge, within which Academic Practice and Teaching is a major strand of provision including specialist courses for new tutees. In 2011-12, nine doctoral degrees were awarded to Cambridge Sociology graduates who have gone on to appointments in a range of sectors.

Research Groups

Individual in the Labour Market Reading and Research group

One of the most active groups in the Department of Sociology is *the Individual in the Labour Market reading and research Group* (ILMrg) directed by Dr Brendan Burchell. The ILMrg has been meeting regularly since 2001 and has an active programme of meetings and social gatherings for teaching staff, post-docs and graduate students; 2011-12 has been another year full of activity.

Thanks to generous sponsorship from the Cambridge Journal of Economics we can cover costs of entertainment and travel for guest speakers, and provide services like business cards for members. Although still primarily a Sociology-based group, we also have members from Geography, Economics, Social Psychology and Management. The group had fortnightly meetings during term-time. In addition to our regular reading-based meetings, in 2011-12 we also had

- A post-dissertation deadline punting trip down the river;
- A seminar on job quality, given by Professor Francis Green followed by a Thai meal for all members of the reading group.

Many members have successfully concluded their time at Cambridge and moved on in the past year. Two of the Reading Group's MPhil students (Albert Arcarons and Vincent Hardy) achieved distinctions; Albert returns to Madrid for his PhD, while Vincent is taking a year out working for the Canadian government before returning to graduate studies.

We were also pleased to be able to welcome an academic visitor to the group this year, Dr Meltem Ince from Yasar University in Turkey arrived in September 2012 to spend most of the academic year in Cambridge, researching gender and labour markets from economic and sociological perspectives.

Several long-standing members of the reading group have left Cambridge this year to taken up lectureships at other universities: Girts Racko (Warwick), Jane Nolan (Leicester) and Sandy To (Hong Kong). This adds to the growing number of universities where members have gone on to work as lecturers and researchers.

Others return (virtually) after long periods away from Cambridge; Nurjk Agloni has been working as a research assistant from Chile on a project on job quality in Latin America with Agnieszka Piasna and Brendan Burchell, having taken the MPhil in Cambridge several years ago.

This year it was a pleasure to have the Social Stratification Conference based in Cambridge in September; both the reading group and this conference grew out of the Social Science Research Group in sociology at Cambridge and have retained close links.

Several members of the reading group have provided research advice for not-for-profit organisations. Alex Wood advised on research for *Boycott Workfare* and Justice *for Interns*, and lectures on job insecurity for *Occupy London*. He also wrote articles on cleaner trade unions for *Red Pepper*. Brendan Burchell gave methods advice for Eliminate Domestic Violence Global foundation as part of the *Peace One Day* campaign, and Brendan Burchell and Julia Gumy provided research for Stella Creasy MP on the *Legal Loan Sharks* campaign.

Many other graduate students and post-doc researchers made a start to their publishing careers with reports, book reviews and conference papers; a selection of their publications is listed in **Appendix C**.

Cambridge Socio-legal Group

Cambridge Socio-Legal Group

The Cambridge Socio-Legal Group was established in 1997 as an interdisciplinary discussion forum concerned with promoting debate on topical socio-legal issues, including those with relevance to policy-making. It is hosted by the Centre for Family Research, Faculty Human Social and Political Science (HSPS), and by the Faculty of Law. The Group serves to bring together people from different faculties across the University (Law, Criminology, Politics, Psychology, Sociology and International Relations, Psychiatry, Biology, Economics, Social Anthropology, and others) as well as prominent socio-legal scholars from other institutions. The Socio-legal Group thus provides a focus for those in the University engaged in socio-legal research, and a basis for linking with the broader world of socio-legal scholarship in the Britain and abroad. The Group also aims to encourage and supports its individual members to work collaboratively, thus fostering inter-disciplinary cross-fertilisations. To this end, the Group holds occasional seminars, at least one a term. Future projects include an interdisciplinary symposium on 'Birth Matters' and possibly one on the 'Home'.

Symposia and Book Projects

The Group is best known outside Cambridge for its successful series of book projects, which have ranged across a wide range of issues. These projects are enhanced by contributors and other discussants coming together in a residential seminar across several days to discuss work in progress, providing participants with the benefit of insights from each others' research. Past projects include:

- What is a Parent? A Socio-Legal Analysis (1999) edited by Andrew Bainham, Shelley Day Sclater and Martin Richards, concerned with legal and social conceptions of parenthood and resulted in publication of the book.
- Body Lore and Laws (2002) edited by Andrew Bainham, Shelly Day Sclater and Martin Richards, on law and the human body.
- Children and their Families: Contact, Rights and Welfare (2003) edited by Andrew Bainham, Bridget Lindley, Martin Richards and Liz Trinder, on contact between parents, children and other family relations.
- Sexuality Repositioned: Diversity and the Law (2004) edited by Belinda Brooks-Gordon, Loraine Gelsthorpe, Martin Johnson and Andrew Bainham.
- Kinship Matters (2006) edited by Fatemeh Ebtehaj, Bridget Lindley and Martin Richards, on evolving notions and practices of kinship in contemporary Britain and the interrelationship of kinship, law and social policy.
- Death Rites and Rights (2007) edited by Belinda Brooks-Gordon, Fatemeh Ebtehaj, Jonathan Herring, Martin Johnson and Martin Richards, examining the ways in which death is experienced in various aspects of modern society.
- Regulating Autonomy: sex, reproduction and families (2009) edited by Fatemeh Ebtehaj, Emily Jackson, Martin Richards and Shelley Day Sclater

- Sharing Lives, Dividing Assets: An Inter-Disciplinary Study (2009) edited by Joanna Miles and Rebecca Probert.
- Birth Rites and Rights (2011) edited by Fatemah Ebtehaj, Jonathan Herring, Martin H Johnson and Martin Richards, a multi-disciplinary collection of essays concerned with the varying circumstances, manner, timing and experiences of birth.

The Group's most recent project was a symposium on *Intoxication: Problematic Pleasures*, held in March. This was a exciting symposium which focused on medical expertise and understandings of intoxication in historical perspective, health expertise in the 20th century, expert and lay knowledge's in exculpatory intoxication in criminal law, the relation of inebriety to insurance, drinking and state formation, the cultural domestication of intoxicants, binge drinking, self and intoxicant experience: a scientific perspective and popular print and Renaissance drinking cultures, embodied memory and intoxication problems, 'losing control' in early modern literature and praxis, interaction and the loss of self-control. The lively debate which ensued reflected interest from law, sociology, history, criminology, psychology, cultural theory, and health studies. A book is in preparation, edited by P. Withington, D. Weinberg, C. Regan and J. Herring.

David Howarth, Reader in Private Law, Fellow of Clare College, and previous Member of Parliament for Cambridge, during which time he served as a member of the Justice and Environmental Audit Select Committees and as Shadow Energy Minister and Shadow Secretary of State for Justice for the Liberal Democrats, on *The Decline and Fall of Lawyers in the House of Commons and what it means for British Politics*.

Zoe Lodrick, a Psychotherapist who specialises in the psychology of sex offending, and has trained police forces, criminal barristers and judges all over the country, on *The*

Psychology of Rape, (considering both sex offenders and their victims) (organised by the Faculty of Law, and sponsored by the Cambridge Socio-Legal Group).
