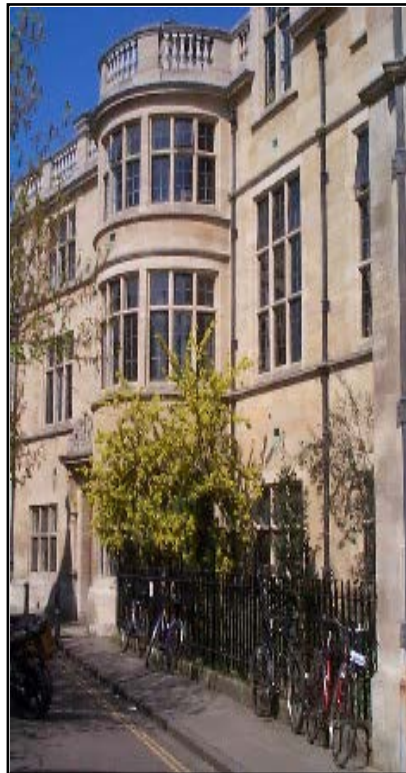

# **Report by the Head of the Sociology Department**

The Department of Sociology became a stand-alone department within the Faculty of Human and Social Sciences in August 2012. This new arrangement has been a great success already, with a clearer identity for Cambridge Sociology, and noticeably enhanced esprit de corps for the graduates and staff alike. The Department of Sociology is rapidly establishing itself as the hub of networks and research within the University including Politics, Social Anthropology, Geography, Economics, Public Health, Public Policy, Migration, Medicine, Education, Criminology and Media.

The new Human Social and Political Science Tripos, is about to be launched, as from October 2013. There has been a very good reaction from schools and individual pupils to the new course, and the numbers of applicants exceeded expectations in both quality and quantity, with considerable enthusiasm for the sociology pathways.

The department was thrilled that one of our Directors of Research, Professor Manuel Castells, won the very prestigious Balzan prize.

## **Teaching**

Sociology in Cambridge continued to win acclaim for its undergraduate teaching programme. Cambridge Sociology was top again in the 2014 edition of the Complete University Guide, and also topped the Guardian University Guide. This exceptional record of success attests to Cambridge's standing both nationally and internationally as one of the pre-eminent institutions for the study of sociology.

The graduate community in sociology remains large and vibrant. It was particularly rewarding in the past year to see so many PhD students drawing upon their research to contribute to national and international debates in the media. Graduate numbers are now the highest ever in Sociology, and the fortnightly pre-seminar lunches have proved very popular as the meeting place for graduates and Faculty.

## **Departmental Seminars**

The Department continued its high profile series of Sociology Seminars and open lectures. We had a number of well-known speakers, including Ken Shadlen (LSE), Jeffrey Alexander (Yale), Manuel Castells (University of Southern California), Erica Haimes (Newcastle University), Carl Tognato (University of Adelaide), Robert Wade (LSE), Claus Offe (Hertie School of Governance). The Seminars were well attended by staff and graduate students, and they provided a forum in the Department for the lively discussion and debate of sociological research.

## **Publications**

All members of the Department have been very active in research. A fuller account of the publication outputs can be found elsewhere in the Annual Report, Now that we are amassing the best publications from the department over the past six years for our Research Excellence Framework submission, the quality and breadth of the department's research over that time is enormously impressive.

### **Media, Press and Outreach**

The Department's research has featured widely in the press. For instance news reports have drawn upon the department's research on everything from the Arab Spring (Kandil) to Pharmaceutical drug pricing (King), from the Gender Pay Gap (Blackburn) to Single women in China (To), and from gendercide (King) to new reproductive technologies (Franklin) and from financial anxiety (Burchell) to zero-hours contracts (Wood). Faculty members have also been invited to speak at public events such as the Hay Festival (Scott) as well as Plenary and Keynote lectures at many conferences. Follow our twitter feed CamSociologyNews to see further details of all these stories and events, and get regular updates.

### **Research Grants**

The Department continued its stellar record in winning research grants to pursue the highest quality research projects. New grants started in this year include the Digital Revolution in Publishing (Thompson) and IVF cultures and history (Franklin).

### **Staff Changes**

We are delighted to be going into the next academic year with many new faces in the department. We have two new UTOs, recruited in 2012-13: Dr Manali Desai, a lecturer in political sociology, and Dr Maria Iacovou, reader in Quantitative Sociology. We also have an impressive list of new researchers joining our existing and new research projects: Liberty Barnes, Rory Coulter, Zeynep Gurtin, Jonathan Kennedy, Marcus Morgan.

Several of our current staff moved on to excellent jobs elsewhere: Anke Plagnol had served the department in many ways for many years, and she took a lectureship at The City University. David Stuckler has become a Senior Research Leader at Oxford University; and Aaron Reeves joined him to work on his research project.

## Report by the Director of Undergraduate Education

In 2012-13, 407 undergraduates studied PPS, with 116 students enrolled in Part I PPS, 144 in Part IIA, and 147 in Part IIB. The first year sociology paper was popular: all 116 Part I students took this course, as well as 8 students from Economics and Archaeology & Anthropology. In Part IIA, 18 students opted for the Sociology stream and 13 for the combined Psychology-Sociology stream. In Part IIB, 27 opted for Sociology and 7 for the combined Psychology-Sociology Stream.

Nikita Simpson (King's College) won the **Polity Prize** for Part I. In Part II the Polity Prize went to Joe Davidson of Fitzwilliam College and Victoria Green of Selwyn College. Joe Davidson also won the joint Sociology and Psychology Prize. We congratulate all of them.

As in the previous year, we organised a Social Anthropology and Sociology **Sutton Trust Summer School** in collaboration with our colleagues in the Department of Social Anthropology. Members of our department (Dr Liberty Barnes, Dr Brendan Burchell, Dr Shana Cohen, Dr Peter Dickens and Dr Michael Rice) taught half of the course; Patrick Baert was the organiser. The Sutton Trust Summer School is aimed at year 12 students from UK-state-maintained schools. The feedback from both students and lecturers was very positive.

## Report by the Director of Graduate Education

**PhD admissions** for the year 2013-2014 rose to 23, and 11 students successfully passed their examinations in the period 1 October 2012 to 1 October 2013, bringing the total number of students registered for the Phd in Sociology to 93. **MPhil admissions** for 2013-2014 were also 23, following a year in which 21 graduated from the programme, receiving 4 Distinctions, 7 High Pass and 10 Pass degrees. The Department received 68 applications for MPhil places for 2013 entry, as well as 76 applications for the PhD programme, bringing the total postgraduate application pool to 144, a decrease of 2 from the previous year, and down 45 (or 30%) since 2007.

Although PhD application numbers have been increasing, MPhil applications have been declining, and a decision was consequently taken during the academic year 2012-13 to revitalise the MPhil 'Modern Society and Global Transformations' by adding more specialised streams in four areas, including an MPhil in the Sociology of Reproduction, (and 3 more). It is hoped in this way to reverse the decline in MPhil applications and to increase the quality of applicants. Note was taken at the Departmental Away Day in October 2013 of the need to emphasise the relatively high level of mark required for the Distinction in the MPhil degree (75), and the need to use the full range of marks to reflect this scale.

As in previous years, a full programme of doctoral training and support was provided in 2013-2014, including a successful seminar series of work in progress set up and run by the PhD students themselves. # Research Groups

## Individual in the Labour Market Reading and Research group

One of the most active groups in the Department of Sociology is *the Individual in the Labour Market reading and research Group* (ILMrg) directed by Alex Wood with support from Dr Brendan Burchell. The ILMrg has been meeting regularly since 2001 and has an active programme of meetings and social gatherings for teaching staff, post-docs and graduate students; 2012-13 has been another year full of activity as witnessed by the fact that this year ILMrg members doubled the number of conference papers which they presented.

Thanks to generous sponsorship from the Cambridge Journal of Economics we can cover costs of entertainment and travel for guest speakers, and provide services like business cards for members. Although still primarily a Sociology-based group, we also have members from Geography, Economics, Social Psychology and Management. The group had fortnightly meetings during term-time. In addition to our regular reading-based meetings, in 2012-13 we also had:

- A post-dissertation deadline punting trip down the river
- A seminar on job insecurity and precarity, given by Dr Kevin Doogan, University of Bristol, followed by a Thai meal for all members of the reading group
- A seminar on 'Decent Work' and the 'Human Development Index' given by Kirsten Sehnbruch, University of Chile, followed by a Thai meal for all members of the reading group

Many members have successfully concluded their time at Cambridge and moved on in the past year. Three of the Reading Group's MPhil students - Manoela Carpenedo, Emre Irdam and Richard Dent - will be returning next year to undertake their PhDs. Two of the reading group's long term members, Achim Edelmann and Julia Gumy, successfully completed their PhDs.

This year also saw long-standing member of the reading group Julia Gumy leave Cambridge to take up a lectureship at Kent University, along with long-standing members Achim Edelmann and Agnieszka Piasna who take up research posts at Duke University and the European Trade Union Institute respectively. This adds to the growing number of universities where members have gone on to work as lecturers and researchers.

This year it was a pleasure to once again have the Social Stratification Conference based in Cambridge in September; both the reading group and this conference grew out of the Social Science Research Group in sociology at Cambridge and have retained close links.

Members of the reading group have been active in engaging in the public debate around work, employment and labour market issues. Yang Hu provided media

interviews on educational reformation and transformation, urbanization, social class and inequality, and ageing and gendered labour in contemporary China to major media outlets: *Xinhua News Agency*, *China News*, *Sina News*, *Phoenix (Fenghuang) News*, *163.com*. Alex Wood wrote articles on trade unions and Walmart for *Red Pepper*, *The New Internationalist* and *Open Democracy*.

Many graduate students and post-doc researchers made a start to their publishing careers with journal articles, reports, book reviews and conference papers. Alex Wood won the Work Employment and Society prize for best PhD paper for his presentation on 'Flexible Despotism: Power, Control and Zero Hour Contracts'.

## **Cambridge Socio-legal Group**

The Cambridge Socio-Legal Group provides an interdisciplinary discussion forum promoting debate on topical socio-legal issues and is affiliated with several departments across the University, bringing together people from within Cambridge and farther afield from different disciplines, including Law, Criminology, POLIS, Sociology, Psychology, Psychiatry, Physiology, Development & Neuroscience, Biology, Economics, History and Social Anthropology. It provides a focus for those in the University and beyond who are engaged in socio-legal research and supports collaborative, inter-disciplinary work through its various activities, in particular its workshop and book projects.

### ***Symposia and Book Projects: 2012-13 publications and plans***

The Group is best known for its successful series of book projects, enhanced by contributors and other discussants coming together in a residential seminar across several days to discuss work in progress in an inter-disciplinary forum.

2012 marked the publication of the most recent book in the CSLG workshop series: [\*Intoxication and Society \(2012\)\*](#) edited by Jonathan Herring, Ciaran Regan, Darin Weinberg and Phil Withington and covering a wide variety of disciplines, including law, sociology, history, criminology, psychology, cultural theory, neuroscience and health studies. Contributions to the volume address various topics, including: medical expertise and understandings of intoxication in historical perspective; health expertise in the 20<sup>th</sup> century; expert and lay knowledges of intoxication in criminal law; the relation of inebriety to insurance; licensing and state formation; the cultural domestication of intoxicants; binge drinking; the self and intoxicant experience; popular print and Renaissance drinking cultures; embodied memory and intoxication problems; 'losing control' in early modern literature; praxis, interaction and the loss of self-control; neuroscientific study of addiction; and chapters on legal and other concepts of responsibility in relation to intoxication.

Preparation for the Group's next project – on *Marriage Rites and Rights* – is well underway, convened by Joanna Miles (Law), Perveez Mody (Social Anthropology) and Rebecca Probert (Law, University of Warwick). The project examines the various rites and rights associated with contemporary marriage practices in the UK, and involves participants from law, demography, divinity, philosophy, psychology, social anthropology, and sociology from a number of UK universities. The workshop will take place in April 2014.

The following project, *Conceptualising Care*, is being convened by Loraine Gelsthorpe (IoC) and Perveez Mody. An international group of participants is to be invited alongside Cambridge academics from various faculties for a workshop provisionally scheduled for January 2015.

### ***Seminars***

Members were invited to various seminars at the Institute of Criminology and Centre for Family Research. Various plans for 2013-14 are currently in hand, and may

include the introduction of a regular methods seminar engaging (in particular) early career academics in the Law Faculty who have an interest in empirical research on legal issues.

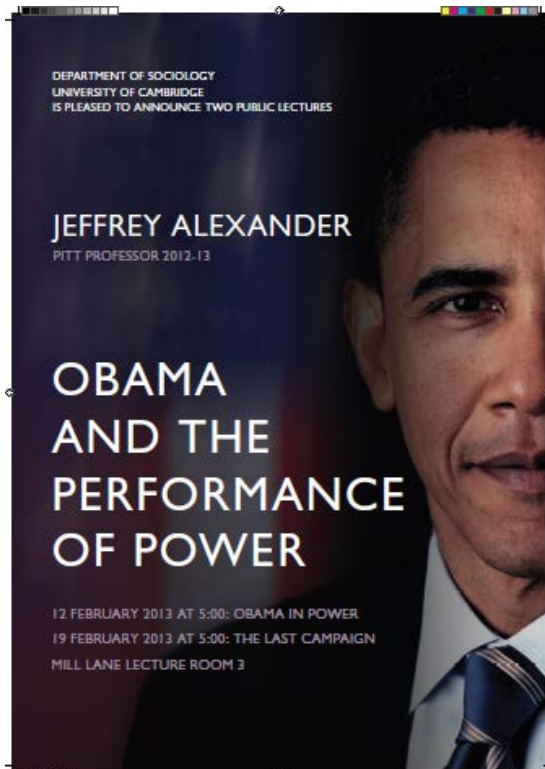

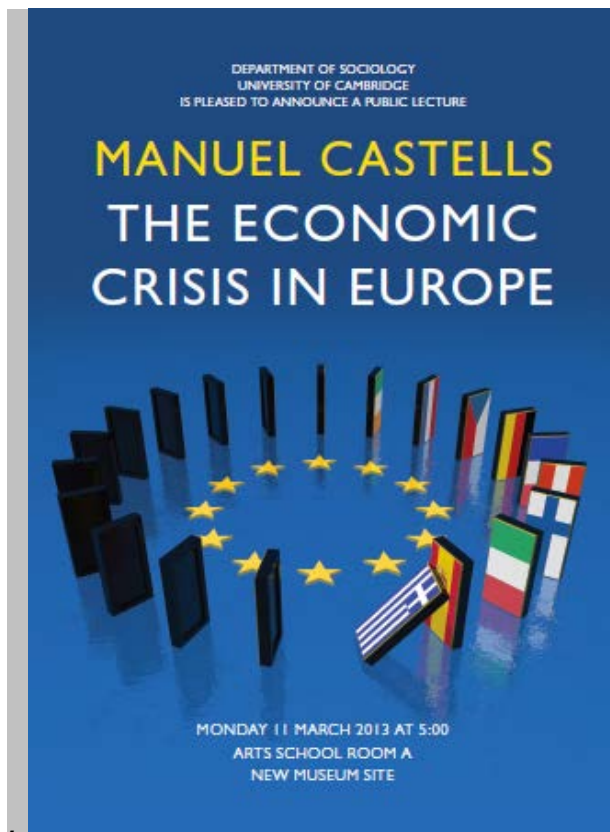

Whereas his previous two books examined the overall transformation of academic and trade publishing over the last 50 years, this new project focuses specifically on the digital revolution and its impact on the publishing industry. It will examine how both established publishers and new start-ups on the

margins on the field respond to the challenges of digitization and seek to innovate in a rapidly changing information environment. It will also explore the broader implications of these developments in terms of the role of technology in the creative industries and the future of the book and other forms of cultural dissemination. This project is funded by a three-year grant from the Mellon Foundation (2013-2016).

The second project is a continuation of the collaborative research with Manuel Castells and others on the financial crisis and its aftermath. Following the publication of *Aftermath: the Cultures of the Economic Crisis*, we are now developing a new research project on 'The Crisis of Europe' that focuses on the multi-dimensional crisis that has been unfolding in Europe over the last few years. This will include the crisis of the euro; the implementation of austerity programmes and their consequences; the crisis of legitimacy and trust; and the experience of, and responses to, the crisis in different parts of Europe. This project will be funded for three years (2014-2016) by the Balzan Foundation in Zurich, the Gulbenkian Foundation in Lisbon and the College d'Etudes Mondiales in Paris.
